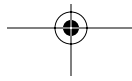

Beeke is president and professor of systematic theology and homiletics at Puritan Reformed Theological Seminary and pastor of the Heritage Netherlands Reformed Congregation in Grand Rapids, Michigan. His numerous publications include *Assurance of Faith: Calvin, English Puritanism, and the Dutch Second Reformation* (New York: Peter Lang, 1991), and *Reformed Confessions Harmonized* (Grand Rapids: Baker, 1999), which he coedited.

John Coffey is a reader in early modern history in the School of Historical Studies at the University of Leicester, United Kingdom. His recent books include *Persecution and Toleration in Protestant England* (Harlow: Longman, 2000) and *Politics, Religion and the British Revolutions: The Mind of Samuel Rutherford* (Cambridge: Cambridge University Press, 1997). He has also contributed articles to a broad range of journals, including *Historical Journal* and *Evangelical Quarterly*.

J. Ligon Duncan III is the senior minister of First Presbyterian Church, Jackson, Mississippi, and adjunct professor of theology at Reformed Theological Seminary (Jackson). He is founder and editorial director of Reformed Academic Press. He edited, revised and introduced Matthew Henry's *Method for Prayer* (Fearn, Ross-shire, Scotland: Christian Focus, 1994), and edited, annotated and introduced Donald Macleod's *The Humiliated and Exalted Lord: A Study of Philippians 2 and Christology* (Greenville, S.C.: Reformed Academic Press, 1994). He has written for both academic journals and popular magazines.

Sinclair B. Ferguson is professor of systematic theology at Westminster Theological Seminary, Dallas. He is the author of many books, including *John Owen on the Christian Life* (Edinburgh: Banner of Truth Trust, 1987); *The Holy Spirit* (Downers Grove, Ill.: InterVarsity Press, 1996); and *The Grace of Repentance* (Wheaton, Ill.: Crossway, 2000). He also served as coeditor with Donald Alexander for the book *Christian Spirituality: Five Views of Sanctification* (Downers Grove, Ill.: InterVarsity Press, 1998).

Ronald N. Frost is associate professor of historical theology and ethics at Multnomah Biblical Seminary in Portland, Oregon. In addition to his scholarly work on Richard Sibbes





and the history of affective theology among Puritans, Frost authored *Discover the Power of the Bible* (Eugene, Ore.: Harvest, 2000).

Randall C. Gleason is professor of systematic theology at the International School of Theology—Asia in Manila, Philippines. He is author of *John Calvin and John Owen on Mortification: A Comparative Study in Reformed Spirituality* (New York: Peter Lang, 1995) and has contributed articles to a broad range of journals, including *Bibliotheca Sacra*, *New Testament Studies* and *Tynedale Bulletin*.

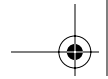

Michael S. Horton is the president and chairman of the Council of the Alliance of Confessing Evangelicals, and is professor of apologetics and theology at Westminster Theological Seminary in California. His doctoral work at Wycliffe Hall, Oxford, focused on the theology of Thomas Goodwin. He has written or edited books not only for scholars but also for laypeople, including *Putting Amazing Back into Grace* (Nashville: Thomas Nelson, 1991), *A Confessing Theology for Postmodern Times* (Wheaton, Ill.: Crossway, 2000), and most recently, *Covenant and Eschatology: The Divine Drama* (Nashville: Westminster John Knox, 2002).

Kelly M. Kopic is assistant professor of theological studies at Covenant College in Lookout Mountain, Georgia. He has written "Communion with God: Relations between the Divine and the Human in the Theology of John Owen" (Ph.D., King's College London, 2001). Recently he has also published "The Son's Assumption of a Human Nature: A Call for Clarity" in the *International Journal of Systematic Theology* (July 2001) and "The Humanity of Christ: Looking at Jesus, Ourselves, and Pastoral Ministry" in *Foundations* 45 (2000).

Paul Chang-Ha Lim is assistant professor of historical and systematic theology at Gordon-Conwell Theological Seminary in Wenham, Massachusetts. He is the author of *In Pursuit of Purity, Unity, and Liberty: Richard Baxter's Puritan Ecclesiology in Context* (Leiden: Brill, 2004), and has written articles for *The New Dictionary of National Biography* (Oxford: Oxford University Press, 2004); *The Dictionary of Historical Theology* (Grand Rapids: Eerdmans, 2000); *Persecution and Pluralism: Calvinist Minorities in Early Modern Western Europe* (New York: Peter Lang, 2001); and *Biographical Dictionary of Evangelicals* (Downers Grove, Ill.: InterVarsity Press, 2002).

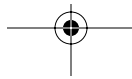
